In 2014, nearly a billion children lived in countries affected by conflict and currently make up more than half of all refugees and nearly half of the world's displaced population. However, children are often unseen, unheard and unaccounted for; their specific needs left unaddressed. Humanitarian crises can affect a significant proportion of a child's formative years, impacting their safety, survival, growth and development. When lives are uprooted, the systems working to keep children safe – in their homes, schools and communities – may be undermined or damaged, increasing a child's vulnerability to all forms of violence and exploitation. Child protection and education interventions continue to be underfunded, even though they are frequently identified by children, parents and caregivers as top priorities in humanitarian crises.

This side-event will bring together child rights advocates, child protection actors and supporters who will present solutions, based on evidence and research, and promote innovative partnerships to ensure adequate funding and galvanize support for lifesaving child protection interventions, including interventions to address the worst forms of child labour in humanitarian response mechanisms.
